COMPOSITION OF THE ANTI –RAGGING COMMITTEE

The Institution has formed an Anti-Ragging committee with the Principal as the chairman. This committee effectively controls Ragging, which is violation against the fundamental human rights and human values. At the commencement of the academic Session, the chairman shall convene and address a meeting of various functionaries like representatives of students, parents/guardians, faculty and district administration including police to discuss the measures to be taken to prevent ragging in the institution.

COMPOSITION OF ANTI-RAGGING COMMITTEE

RESPONSIBILITY OF ANTI-RAGGING COMMITTEE

- Beginning of every academic year, the committee forms Anti-Ragging squads for the control of ragging activities inside the campus.
- The squad members are assigned with various duties at the crowded areas of the college campus to prevent the fresher's from any unwanted activities.
- The committee makes surprise visits to hostels and other vulnerable places prone to ragging. This committee ensures the campus Ragging-Free.
- Anti-ragging slogans are displayed in main areas of the campus and in college website.
- The contact numbers of the committee members are displayed in all notice boards through which students can contact the committee members 24 x7 for their grievances and to resolve it.
- Anti ragging forms shall be collected from students by the committee.

Rules:

1. Students are advised to follow anti ragging rules and regulations issued by the AICTE ,UGC and Anna university
2. Students seeking admission to the hostel shall have to submit undertaking states that he/she is aware of the law in this regard and agrees to abide by the punishment meted out to his/her in case of abetting ragging

Punishment:

1. The punishment to be met out to the persons pampered in ragging has to be exemplary and justifiably harsh to act as a deterrent against recurrence of such incidents. The Students who found to be involved in ragging be debarred from institution
2. Depending upon the nature and gravity of the offence as established by the Anti-Ragging Committee of the institution, the possible punishments for those found guilty of ragging at the institution level shall be any one or any combination of the following.
 - (i) Cancellation of admission
 - (ii) Suspension from attending classes
 - (iii) Withholding/withdrawing scholarship/fellowship and other benefits
 - (iv) Debarring from appearing in any test/examination or other evaluation process
 - (v) Debarring from representing the institution in any regional, national or international meet, tournament, youth festival, etc.
 - (vi) Suspension/expulsion from the hostel
