15. Multidisciplinary / interdisciplinary

Karpaga Vinayaga College of Engineering and Technology (KVCET) is an age-old institution affiliated to Anna University. The curriculum is designed based on CBCS (Choice Based Credit System) pattern as directed by the affiliating university. The courses are categorized as follows: i) Humanities, Social Sciences and Management Courses (HSMC) which includes Professional English, Communication skills etc. ii) Basic Sciences Courses (BSC) which includes Mathematics, Physics, Chemistry, Biology, Environmental Science etc. iii) Engineering Sciences Courses (ESC) which includes Engineering Practices, Engineering Graphics, Basics of Civil / Mechanical / Electrical / Biomedical/ BioTechnology/ Electronics / Instrumentation, Computer Engineering, etc. iv) Professional Core Courses (PCC) comprising the core courses relevant to the chosen specialization/branch. v) Professional Elective Courses (PEC) comprising the elective courses relevant to the chosen specialization/ branch. vi) Open Elective Courses (OEC) which includes the courses offered by a branch to other branches, from the list specified in the respective curriculum of the B.E. / B. Tech. / B. Arch. Programmes. Vii) Employability Enhancement Courses (EEC) which includes Project Work, Internship, Seminar, Professional Practices, Case Study and Industrial/Practical Training etc. viii) Audit courses (AC) which composes of the courses such as Constitution of India, Sangam literature etc. The institution will offer a multidisciplinary flexible curriculum that enables multiple entries and exits at the end of 1st, 2nd and 3rd years of undergraduate education, once it becomes autonomous. The institution is undergoing the process of getting autonomous status. Apart from the above acknowledged and prescribed category of courses, the students are encouraged to learn any multidisciplinary/interdisciplinary courses through our Innovation Lab and Industry supported Lab which provides "Learning through experience" arena. NEP 2020 suggests that the colleges will be "gradually phasing out the system of 'affiliated colleges' over a period of fifteen years" i.e. by 2035.

The phasing out of the system of "affiliated colleges" shall be supported by the mentoring of the affiliated colleges by the respective affiliating university. We have mooted this to implement in our institution and various steps have been taken

including attending seminars and conferences related to NEP 2020, identifying bench marks from various institutions for multidisciplinary courses and closely following the norms and regulations of the affiliating university.

16.Academic bank of credits (ABC):

KVCET has initiated the process to register under Academic bank of credits via National Academic Depository. Academic bank of credits is a credit facility originally envisioned by the Government of India in the National Education Policy (NEP) 2020. The scheme has the provisions of creating a digital infrastructure that will store the academic credits earned by the students of various higher education institutions within the country.

KVCET is consistently maintaining the data of the academic credits earned by students. It is stored as databases in the systems implanted in respective departments. Implementation of Academic Bank of Credits system with a central database is totally based on the directions given by our affiliating university and Higher Education Department of Tamil Nadu. Considering its importance in mind, this institution makes sure the immediate implementation of Academic Bank Record. This system is inculcated after receiving the guidelines from the regulating authorities.

17.Skill development:

A cardinal requisite of an engineering student is to get equipped with various skills in interdisciplinary areas. KVCET has taken various initiatives to develop the skills of students by training them under Skill development programme "Naan Mudhalvan" which is an initiative of the Government of Tamilnadu and through various technology centres established inside the college premises apart from the laboratory facilities mandated by the regular curriculum. Students are trained by in-house faculty in these centres and certified by various agencies like AUTODESK, Robert BOSCH, IIT Bombay etc. We conduct the value-added courses prescribed by our affiliating university in different disciplines and this would enable them to earn academic credits apart from the skills they acquire Students will be trained in their first semester on activating productive language skills through Cambridge, an initiative of Tamil Nadu Government.

18.Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course)

NEP 2020 envisages a greater Promotion of Indian Languages, Arts and Culture. The NEP document elaborates on the cultural and knowledge heritage of India, the importance of Indian Philosophy in the renewed perception and influence on the world events, the importance of the Multilanguage multicultural background of the country and the necessity for revitalizing these realms for the betterment of the country and the world. This strategy calls for a paradigm shift in our immediate past educational system (which, in general opinion, has devalued the Indian traditional knowledge). To bring back the glory of the ancestoral values and knowledge and a line with AICTE, guidelines the institution has introduced a mandatory course on Indian Constitution and Traditional Knowledge' for all the UG students. To augment the lectures in the class room, standard text books on Indian Constitution and Cultural heritage of India have been given to the students. Through the efforts of Fine Arts Club, competitions are being regularly conducted in the regional language viz Tamil on the contemporary topics on environment, energy conservation, etc., as well as topics on the cultural and ethnic values of India. The Parent University has also introduced two UG courses (B.E.- Civil Engineering and Mechanical) Engineering in Tamil Medium.

19. Focus on Outcome based education (OBE): Focus on Outcome based education (OBE):

All the programmes offered by our institute are well formulated, achievable and measurable with determined Programme Educational Objectives (PEOs), which the graduates would be able to achieve in their career. The curriculum is designed with twelve Programme Outcomes (POs) as prescribed by National Board of Accreditation. Each programme consists of Programme Specific Outcomes (PSOs) which our graduates would be able to present by themselves after completion of the programme. Apart from the above designed outcomes, each course has five to six course outcomes which are formulated in coordination with POs and PSOs. These course outcomes are formulated in such a way that they can be achieved and measured at the end of each course by a distinctive process. The content delivery of each course is meticulously planned at the beginning of the semester and recorded precisely in the lesson plan. The notes of lesson are also prepared by taking the course outcomes as reference and uploaded in the website for the future reference of the students.

Varieties of teaching-learning approaches are implanted in order to achieve the outcomes designed at the beginning. The POs that are not covered in regular content delivery of courses are

thought through experiential learning methods. CO attainment is calculated in a 3-point scale at the end of each course and PO and PSO attainments are consecutively calculated in a 3-point scale at the end of programme. Based on the final attainment levels, the course outcomes will be revised and analyzed whether it requires any modification. All the above outcomes are defined meticulously as the institution strives hard to restore the spirit of NEP.

20.Distance education/online education:

There is a perceptible change in the modes of the Teaching-Learning all over the world and there is a significant shift from all class room teaching and Learning to partly classroom partly online Teaching-Learning. This is exhibited in the worldwide popularity of Online education like MOOCs, etc. India is also keeping abreast in this new paradigm. We encourage our students and faculty to register and write examinations under SWAYAM NPTEL for several years. As per the guidelines of our affiliating University the credits earned from SWAYAM-NPTEL are considered as replacements of elective courses. The list of such courses, are approved by the Principal before the beginning of the semester so that students register for those courses which are relevant for that particular curriculum and not repetitive/duplicative in nature. The online courses have also enabled the students to complete the credit requirements by the 7th semester and in 8th semesters. Students can take up full time internship in suitable industries. This doubly benefits the students to acquire skills required by the industry and also a favorable career opportunity.

1.1 - Curricular Planning and Implementation

1.1.1 - The Institution ensures effective curriculum delivery through a well planned and documented process

Effective curriculum delivery is carried out in the Institution through a well-documented approach.

- In accordance with academic schedules given by the university an Academic Calendar encompassing working days schedule, internal assessment examinations, guest lectures, Industrial visits value added courses etc., is prepared every semester.
- Allocation of subjects to the faculty members is done after careful consideration of their subject expertise besides their choice.
- Course study material such as lecture notes, question bank, lab manuals are prepared by the allotted faculty members focusing on the outcome based education.
- Time tables are prepared in advance every semester for theory, tutorial and practical classes based on the, credits as per the curriculum.

- A Comprehensive lesson plan showing the hourly plan of course delivery is prepared for all the subjects by the allotted faculty members.
- To supplement the curricular gaps and to prepare them for the relevant industry "value added courses" are conducted with the help of industry experts.

After each internal assessment examination, a periodic meeting is conducted in the Department with the faculty members to assess the level of understanding of the students on the topics covered. Special coaching is provided for the slow learners identified through the above process.

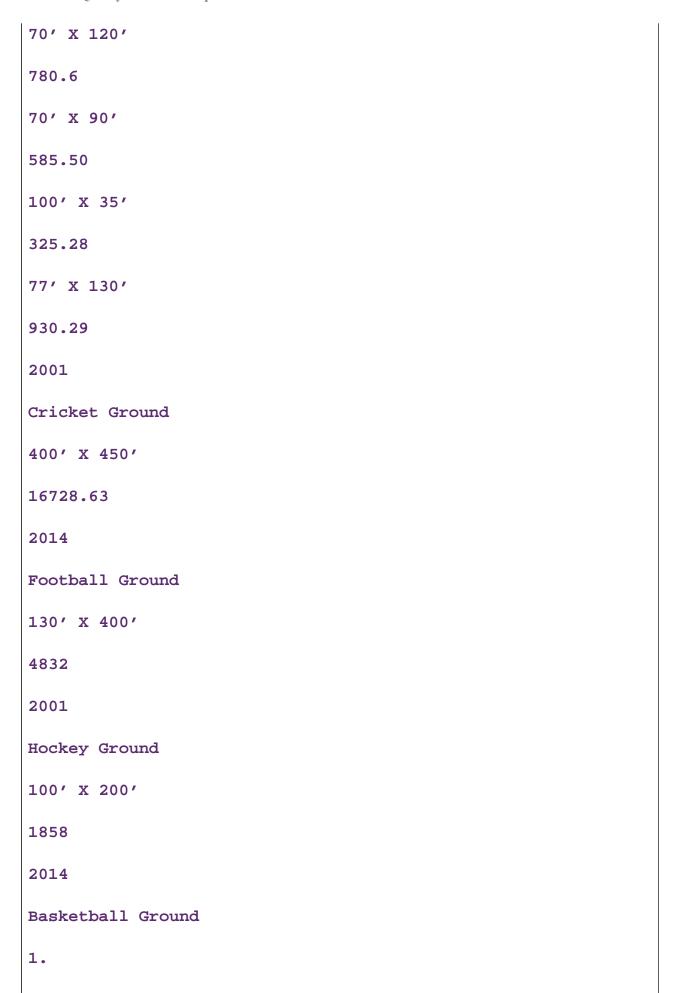
